Vis international Commercial Arbitration Moot —named after Willem Cornelis Vis (1924–1993), a renowned expert in international commercial transactions and dispute settlement procedures — is an annual international moot court competition held in Vienna, Austria. The Vis arbitral moot competition is a collection of simulated arbitral proceedings aimed at fostering study in the field of international commercial and arbitration laws and encouraging the resolution of business disputes by arbitration. The moot consists of submitting written memoranda prior to the moot on designated dates for both sides of the dispute (Claimant and Respondent in legal terminology). The oral arguments phase of the moot is held in Vienna. Pre-Moots are organized in order to help participating teams to prepare for the main event in Vienna.

The Discussion: "Corruption allegations in international commercial arbitration" on 16 March 2012 will take place at the Moscow office of White & Case LLC located in the Romanov Dvor Business Center (4, Romanov street), which is the historical heart of Moscow and only 500 meters from Kremlin.

By Metro: the closest metro stations are «Arbatskaya», «Alexandrovsky Sad» and «Biblioteka imeni Lenina» are only 5 minutes walk from the Romanov Dvor.

As you get out from the station «Biblioteka imeni Lenina» on to Vozdvizhenka Street, walk down Vozdvizhenka Street, turn right to Romanov pereulok (there would be a direction «Romanov Pereulok») and the buiding 4, which is Romanov Dvor Business Center, would be on right side.



The Rounds on 17-18 March 2012 will take place at the Faculty of Law of Lomonosov Moscow State University at Leninskiye Gory, Akademica Khokhlova Street, 1st Academic Department of Humanitarian Studies (Pervyi Uchebniy Korpus).

By Metro: the closest metro station is «Universitet» is about 10 minutes to walk from the Faculty of Law.

As you get out of the «Universitet» station on to Lomonosovskiy Avenue (Lomonosovskiy prospekt), cross the Lomonosovskiy Avenue towards the Vernadskogo Avenue (Prospekt Vernadskogo). Continue walking 500 meters down the prospect Vernadskovo. There is an entrance on your leftwhere (opposite the building of roof-rounded circus building) the 1st Academic Building of the Humanities is located.



We specifically note for the teams which stay at Hotel Lomonosov (building 34, Michurinskiy Avenue) that on 16, 17 and 18 March 2012 one of the students from Lomonosov Moscow State University will guide these teams to White & Case office and to the Law Faculty.
